RESOLUTION

The 11th September 2007

In Pursuance of the provisions contained in Paragraph 4.2 of Orissa Public Private Partnership Policy 2007, the State Government after careful consideration have been pleased to constitute an "Empowered Committee on Infrastructure (ECI)". The powers and functions of ECI would include :—

- a) Prioritize, approve shelf of projects, sanction, authorize expenditure for PPP Projects.
- b) Recommend projects for Viability Gap Funding(VGF).
- c) Adopt, adapt and develop Model Concession Agreements (MCA) for various sectors.
- d) Sanction PPP Projects and approval of Concession Agreements for projects with investments up to Rs.500 Cr.
- e) Deliberate and recommend to HLCA the final bids for approval of the projects above Rs.500 Cr.
- f) Deliberate and recommend to HLCA any special grants and concessions.
- g) Coordinate the efforts of other departments for the furtherance of the objectives of this policy.
- h) Inspect, visit, review and monitor any PPP Projects regarding its implementation, execution, operation and management.
- i) Recommend enactment of Special legislation for formation of appropriate regulatory mechanism/robust grievance redressal mechanism as may be required for the project.
- j) Manage the "Orissa Infrastructure Development Fund (OIDF)" proposed to be created to facilitate infrastructure development, to recommend projects along with amount required from the fund to meet the objectives of this Policy.

The Empowered Committee on Infrastructure (ECI) shall consist of the following members.
